  - Mobility (5%) 0
  - Vision/Hearing (2%). 0
- Preference for a percentage of units goes to:
  - Residents of Brooklyn Community Board 9 0 (50%)
  - Municipal employees (5%)

\*Up to half of CB preference units may be allocated through referrals of applicants from city agencies.

Apply online or through mail. To apply online, please go to <u>nyc.gov/housingconnect</u>. To request an application <u>by mail, send a self-addressed envelope to</u>: 195 Sullivan Place Apartments, C/O Reside New York, 381 South 5<sup>th</sup> Street Unit #1 Brooklyn NY, 11211. Only send one application per development. Do not submit duplicate applications. Do not apply online and also send in a paper application. Applicants who submit more than one application may be disqualified.

# When is the Deadline?

Applications must be postmarked or submitted online no later than February 26, 2019. Late applications will not be considered.

### What Happens After You Submit an Application?

After the deadline, applications are selected for review through a lottery process. If yours is selected and you appear to qualify, you will be invited to an appointment of eligibility to continue the process of determining your eligibility. Appointments are usually scheduled from 2 to 10 months after the application deadline. You will be asked to bring documents that verify your household size, identity of members of your household, and your household income.
